1. Description

FeasyBeacon **FSC-BP109** is a USB powered super long range beacon. It simultaneously supports iBeacon, Eddystone (e.g. URL, UID), AltBeacon for broadcasting and provides the ability to advertise up to 10 slots of advertising frames. Transmit distance up to 4000m.

FeasyBeacon Super BP109 is designed to solve the poor cover range problem, suitable for application scenarios like stadium, museum, exhibition, hotel, restaurant, etc.

With the iOS & Android FeasyBeacon SDK, the developers can take advantage of the flexibility of the SDK and focus on their own application, such as Broadcast, Proximity Marketing, Digital Signage, Indoor and Outdoor Location, Asset Tracking, Vehicle Tracking, etc. Meanwhile, FeasyBeacon SDK compiled app is available to download from both the iOS and Android platform (search 'FeasyBeacon' to download).


