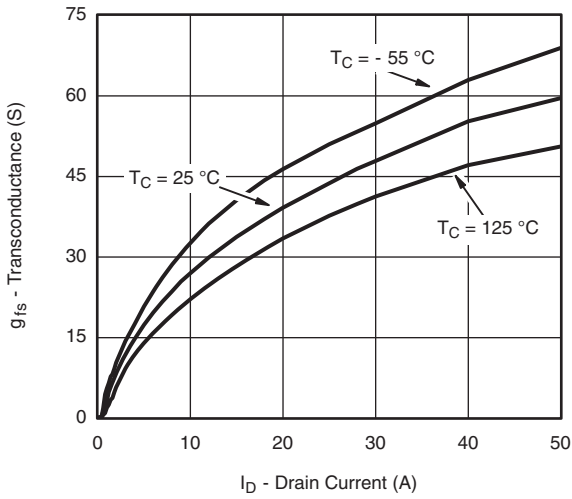

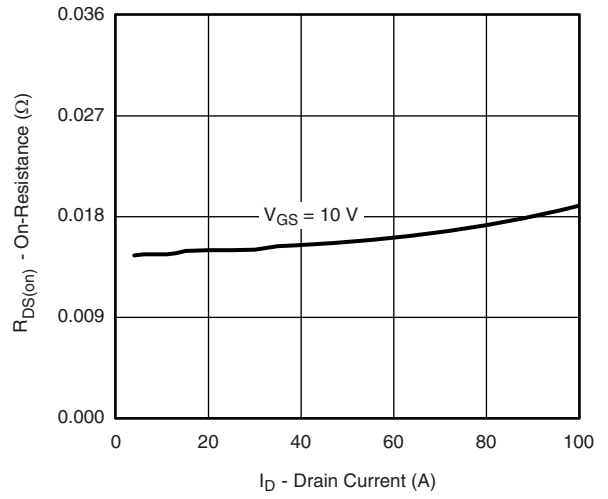

On-Resistance vs. Drain Current



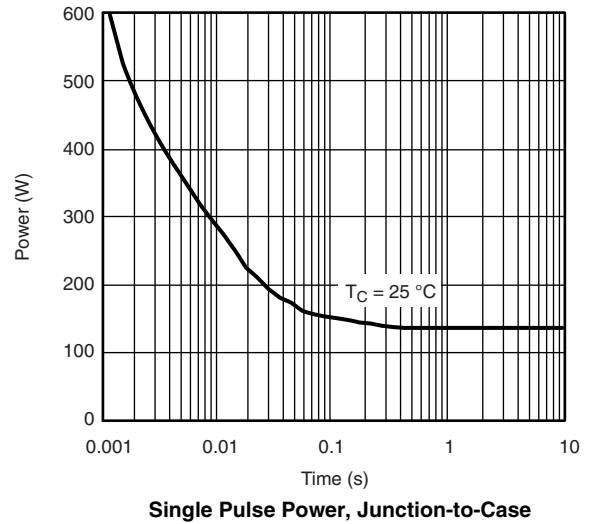
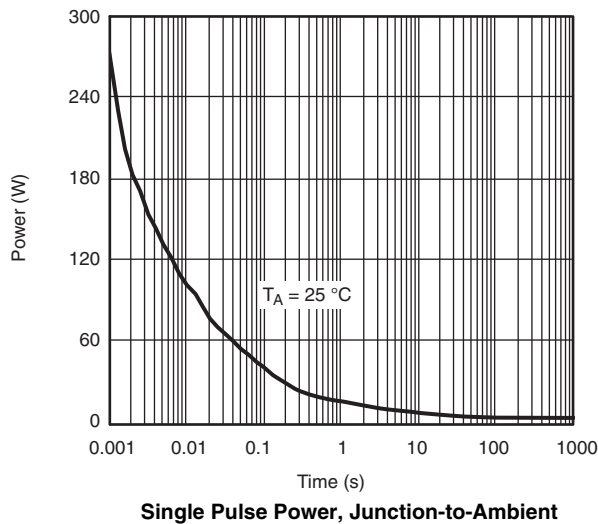
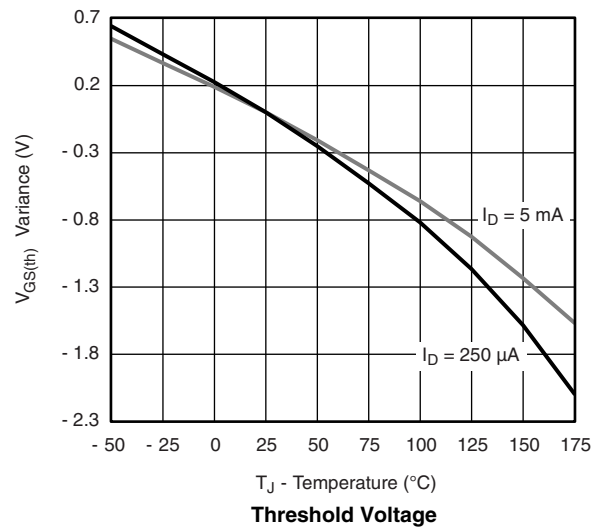
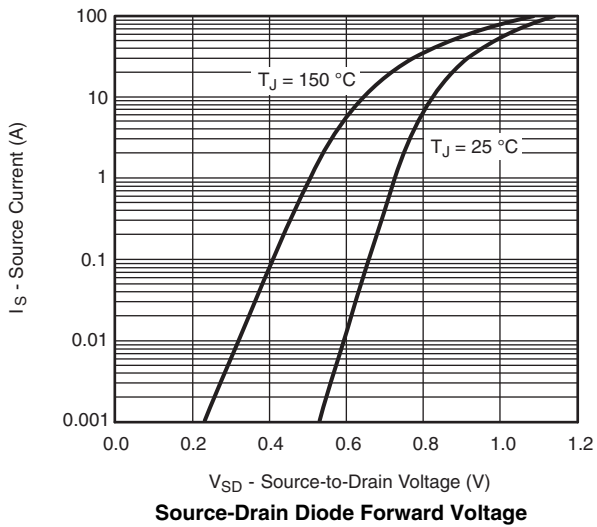
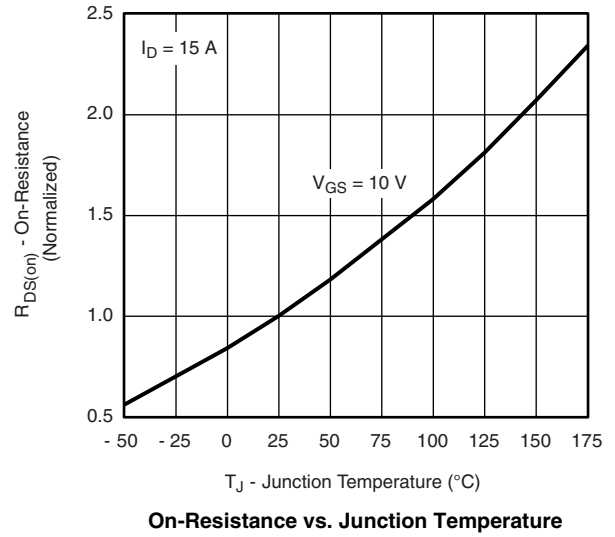
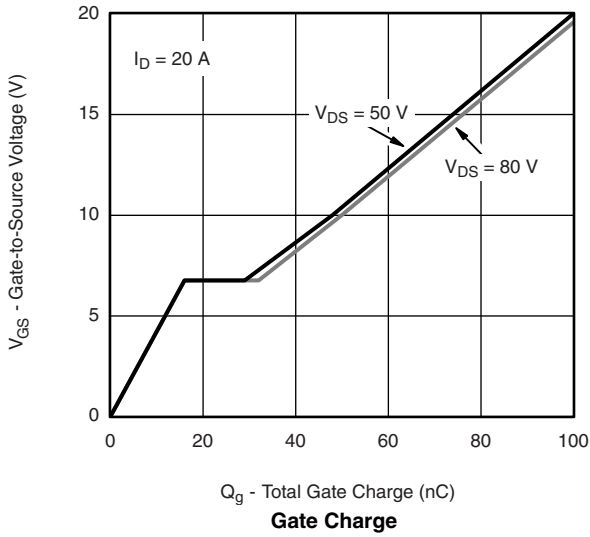
On-Resistance vs. Gate-to-Source Voltage

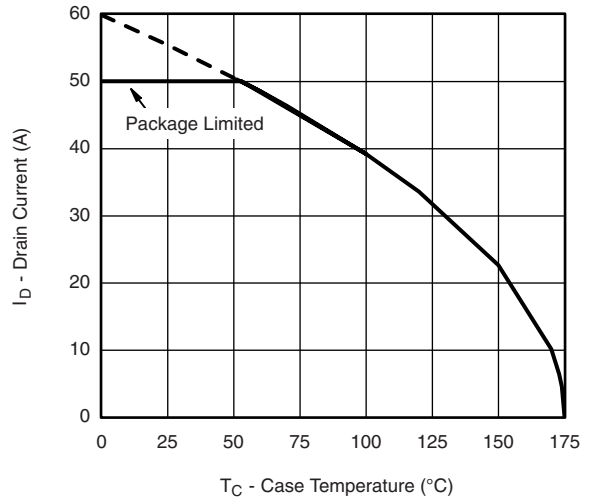

Current Derating, Junction-to-Ambient**

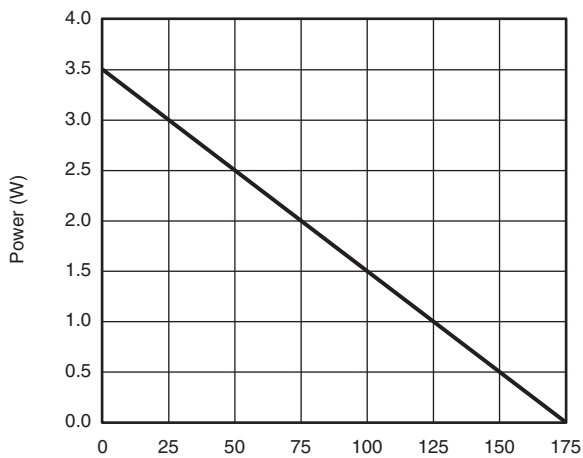

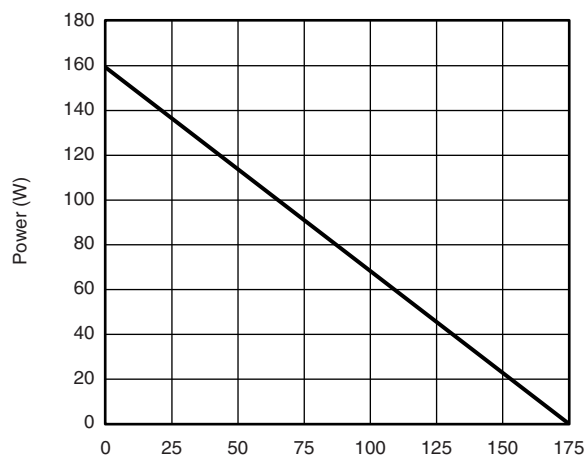

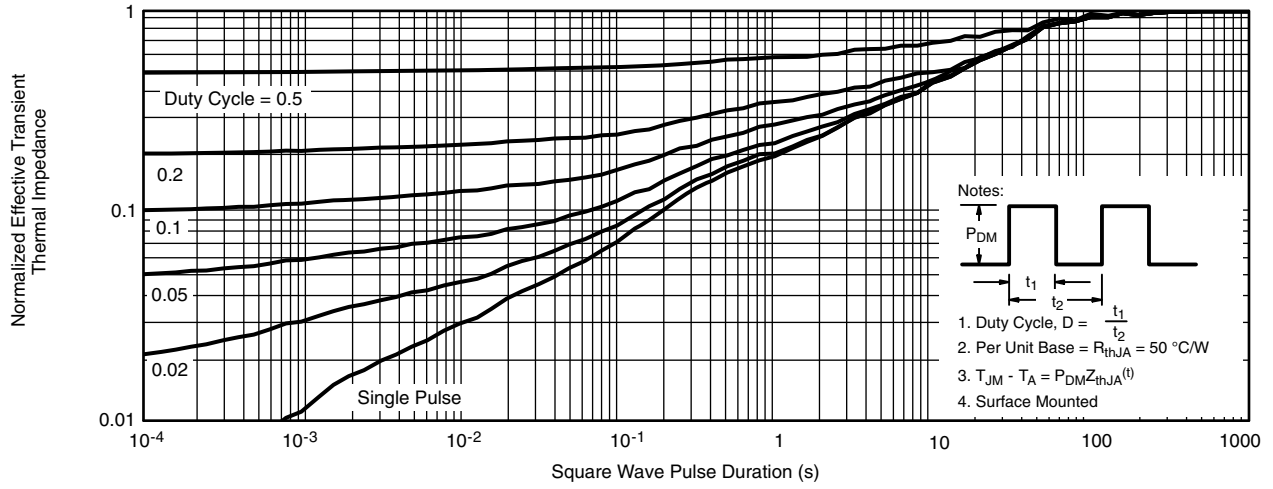


T_C - Case Temperature (°C)

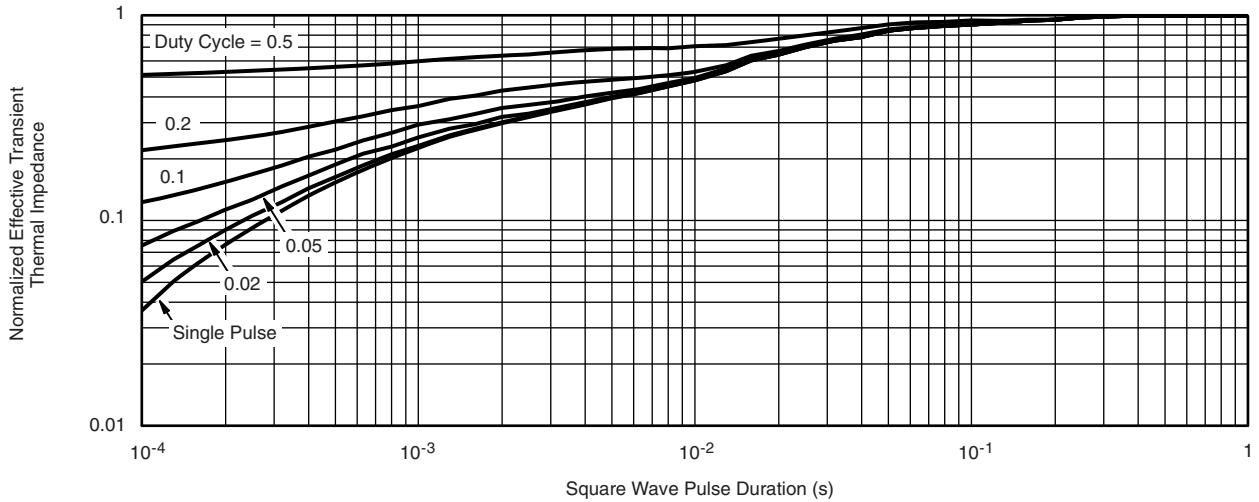
